2. Even if teachers have better teaching methods, they are suffering from the lack of hardware supporting facilities to effectively implement [2]. Secondly, the comprehensive quality of some physical education teachers still needs to be improved. In the case of teachers' low comprehensive quality, it is

- 2. INTEGRATE DIVERSIFIED TEACHING METHODS IN CLASSROOM TEACHING

The second level of students for the mastery of knowledge points and learning ability are general, then the teacher in the teaching of these students, it is necessary to provide them with some help, for example, to select a representative, the teacher to release tasks to him, and then supervise students to complete the knowledge points and basic exercises training, so as to achieve the best teaching effect. For the last level of students, their academic performance is relatively poor, and the classroom does not actively listen to the class, then the teachers of this part of the students' teaching should make more efforts, personally guide and impart knowledge points, help them gradually catch up with the class progress, so as to achieve the effect of improving the overall teaching efficiency.

2.3 Integrating interactive teaching methods

Interactive teaching method is also known as group cooperation teaching mode, which is widely used in all stages of education nowadays. The integration of this method in college computer basic classroom teaching can greatly stimulate students' learning enthusiasm, make them immerse themselves in learning, and then express themselves, to further enrich students' knowledge reserve. The introduction of jigsaw method into listening class is a new attempt for listening course. Therefore, the paper centers on the teaching procedure in a jigsaw classroom and the beneficial effects it produces. After one-year practice, it is found that the students' desire to learn, effective cultivation of students' awareness of responsibility, subjectivity and innovation were greatly improved. Hopefully, based on the students' actual performance and aspirations, jigsaw method will be promoted in other courses in the future.

1.INTRODUCTION

Listening comes first among English learning skills. Listening course is compulsive for English majors in the fundamental stage. According to the course syllabus, listening skills should be effectively trained so that the students may lay a solid foundation for language skills and their competence to analyze and solve practical problems. Consequently, the improvement of their English thinking ability and the level of free expression of their ideas facilitates the achievement of effective communication. Unfortunately, students often find difficulties in listening. Although the teachers already give them some practices before giving the students a listening test, they often fail. Perhaps the failure is caused by the students' strategy in listening. It is stated that "it is important to build up their confidence by making sure that they are armed with strategies which are likely to lead to success". (Burgess et.al 2005:79)

2.ORIGIN OF JIGSAW METHOD

Jigsaw method originates from jigsaw puzzle. In the 1970s, despite the desegregation in America, the

Home Group and Task Division: Home group is set up based on heterogeneous grouping, each of which includes 4-6 students. The number of the students is the same as that of the teaching material parts. One student

interracial hostility, prejudice, and deep-seated distrust in the school system made normal teaching fall into disorder. In such a situation, the American social psychologist Elliot Aronson, and his colleague-initiated jigsaw teaching model, put it into practice in the classroom, and achieved an interdependent, coadjutant and harmonious atmosphere. The introduction of its rules into teaching field produces a new interactive teaching method --- Jigsaw Cooperative Learning.

3.TEACHING PROCEDURE IN LISTENING CLASS

Jigsaw method is a teaching technique which makes it possible for the students to work by making discussion and studying in a group. It requires the student to exchange information with the other group to compose the complete task. Its procedure is as follows:

Task Division: Listening materials will be cut into 3-6 small parts with almost the same difficulty and content quantity. Each student is responsible for one small part. Here is a jigsaw example from *Step by Step 3000 1* Unit 2 *Colorful Lands, Colorful People*.




with good comprehensive abilities is designated as the group leader, responsible for study, discussion, and coordination within the group. In this way, the students may easily grasp the learning tasks and teaching

objectives. A five-person group is like the below patterns.

Expert Group and Task Research: The members responsible for the same task in home groups make up

temporary expert groups, in which they focus on the given listening materials and have a discussion and intensive study.









Collaborative Learning: After spending ten or fifteen minutes in their expert groups, the students go back to their home groups, where they are informed that they have a certain amount of time to share their information to each other. It is advised that if a class is to use jigsaw an hour a day, 20 minutes of the hour should be spent in expert groups and the remaining 40 minutes in the home group.

Teacher's Feedback: During the process of discussion and research, the jigsaw teacher moves about the classroom from group to group, checking how each group is progressing on its task, keeping eyes and ears open for any problems that may be developing (Aronson, 1997:51). After the discussion, the teacher centers on these problems, analyzes relevant knowledge and explains important and difficult points to ensure the students have a better understanding of the listening materials [2-5].

Performance Evaluation: Success is measured through individual quizzes. The prepared quiz paper is given to each student, who is required to finish it independently within limited time. The test should cover each task module and the score of each group is the average score of the members in the same home group.

4.ADVANTAGES OF JIGSAW METHOD

Jigsaw method is a kind of group cooperative learning. It attaches great importance to the teacher's active and effective guidance in class. Its advantages are mainly embodied in the following aspects.

Change of Learning Resource. Jigsaw method changes the basic structure of one expert (the teacher) and listeners (the students) in the classroom. The teacher is no longer the sole resource for the learning groups. Instead, he acts as a backstage designer and the students regard each other as resources. In the group, students pay attention to their peers, asking good questions and helping each other while teachers help students learn more effectively and develop an efficient, comfortable, and cooperative process.

Change from Passive Learning to Active Learning. Students become experts on one aspect of the lesson, meet in expert groups and help others in their group to learn the material. In a jigsaw classroom, interdependence is required which encourages students to actively get involved in the activities. Students' participation in jigsaw classroom activities is much better than that in traditional classrooms.

Improvement of Students' Emotional Quotient. In a jigsaw classroom, students' mutual help deepens their

understanding of the relevant materials. Their language competence and communicative skills are greatly enhanced, which is quite important for the cultivation and improvement of individual emotional quotient. That is exactly what is lacking in current teaching mode. Cultivation of Awareness of Responsibility, Subjectivity, and Innovation. The 2017 classes were divided into ordinary classes and experimental class in their freshman year. Jigsaw method was adopted in experimental class. At the end of the semester, a questionnaire survey and a listening test were conducted. In the process of innovation, we can combine the sensitive period of students' physical quality development and characteristics of students' psychological development, introduce quality development training elements and physical training elements on the basis of traditional sports activities, enrich the contents of large sports activities, promote the development of students' physical and mental health, promote the important role of large class sports activities in physical education teaching, implement the improvement of physical fitness level Department.

3.3 Stimulate students' interest in sports and enhance their participation in sports

Interest is the best teacher, is an important factor to promote students' physical fitness, but also the basic incentive for students to participate in sports activities. Routine activities can no longer meet the personalized needs of students, but also limit the students' interest in participation [8]. Therefore, it is necessary to constantly innovate the large class sports activities, to stimulate students' interest in sports, improve students' participation rate, relieve learning pressure, and at the same time, promote students' physical and mental health and physical fitness, and cultivate the awareness of lifelong exercise.

4. THE PRINCIPLE OF CONTENT INNOVATION OF SPORTS ACTIVITIES BETWEEN CLASSES

4.1 Safety principle

In addition, it is necessary to select the appropriate exercise load according to characteristics of the activity content, focusing on the small and medium-sized exercise intensity, and selecting scientific methods and organizational forms according to the characteristics of physical and mental development and the scope of activities [10]. The selective principle makes the large class activities more targeted, which can improve the sports participation, the quality and effect of activities, and achieve twice the result with half the effort. At the same time, it can reduce the occurrence of sports injuries and the occurrence of safety accidents in activities.

In the aspect of activity organization, we can combine the uniqueness of the content, choose the best activity mode, avoid single collective activity mode, arouse students' desire to participate with diversified activity ways, and promote the efficiency of activity process.

- 5.1 Innovative strategies of consolidating physical fitness elements in the content of quality development training
- 5.1.1 Content innovation strategy of sensitive quality development activities

Sensitive quality refers to the ability to make corresponding reactions, judgments, and decisions when the external environment suddenly changes, which reflects the body's ability to predict and respond quickly and accurately to changes in simple, space, time, and synthesis [11]. Through a long period of practice on students' sensitive quality, students' ability to deal with emergencies can be improved, and the probability of injury and safety accidents can be reduced. In the selection of activity content, we can choose the quality development training project led by sensitivity, and carry out advanced and backward level based on the original project. In the process of activity, teachers should also make clear and strict standards for the time, range, rhythm, and speed of actions [12]. Different standards can be formulated according to different grades and different physical conditions. For example: choose "don't fall into the forest" in the quality development project to practice the students' sensitive quality, and the teacher can control the password to strengthen the sensitive quality practice in the project (the original project rule is that the students in the group agree their own password). If students have their own unified password, they will choose their own most suitable rhythm. However, if the teacher gives the password, they can break the original rhythm of students by varying the pace, so that they must make judgment and action faster when hearing the password, to successfully complete the challenge.

5.1.2 Content innovation strategy of speed quality development activities

Speed quality is one of the basic qualities of human body, which mainly includes reaction speed, displacement speed and action speed. In the sensitive period of speed quality, taking certain methods and means to develop the speed quality of primary and secondary school students is of great significance for the development of sports ability and the cultivation of good physical quality [13]. And the speed quality is also a must test content in the high school entrance examination sports. From the primary school stage, we should pay attention to the speed quality training, which will lay a certain foundation for the high school entrance examination sports to achieve excellent results. For example: select the "supersonic" in the quality development project to promote the development of students' speed quality. When going, we can use rope ladder to place obstacles, and require students to adopt different ways to pass through different obstacles, to promote the practice of students' reaction speed; in the process of returning, we can ask students to run speed or running frequency, to promote students' speed Practice of displacement velocity. In the process of running, because of the acceleration of running speed or frequency, students can improve the practice of their movement speed.

5.1.3 Content innovation strategy of endurance quality development activities

Endurance quality is the ability of body to resist fatigue for a long time, and it is an important index to reflect the level of human health. Primary and secondary school students need to maintain a relatively fixed posture for a long time in their daily class or homework. Excellent endurance quality is the necessary premise for students to listen carefully and finish homework seriously. In addition, in sports test, medium and longdistance endurance running is also an important part of students' test. The purpose of this paper is to improve the physical function of primary and secondary school students through the training of endurance quality in physical education teaching, and at the same time, cultivate the students' spirit of hard work and perseverance. For example, to improve students' endurance quality, we can add a new rope skipping method on the basis of the traditional rope skipping method of "around eight characters", or require students to do some simple other actions, such as squat jump, one foot jump and so on, and increase the time of rope skipping, so as to achieve better training effect.

5.1.4 Content innovation strategy of flexible quality development activities

Flexibility quality refers to the movement ability of human joints in different directions and the stretching ability of soft tissues at each joint. It is an important part of human body quality. Good flexibility is the ability necessary for human body to complete daily life, an important quality to prevent injury or reduce injury degree, and one of the important guarantees to improve other qualities [14]. For example: choose the "reverse bow over the pole" in the outward-bound training project to exercise the students' flexibility quality. Students can be required to clap their heels (when they can't reach their feet, they can pat their buttocks or the back of the legs) and insist on the specified time, to make the joints stretch more fully.

5.1.5 Content innovation strategy of strength quality development activities

Strength quality refers to the ability of muscle to overcome resistance at work. Muscle strength needs to reach a certain degree to maintain normal life and engage in various body movements. For the primary and secondary school students who are in the sensitive period of physical development, we should focus on the development of the whole-body muscle strength, and avoid excessive large strength exercise, to avoid injury. For example: choose the ice breaking game "radish squat" in the quality development project to exercise the strength quality of students, can improve the students' squat mode, from the original double leg squat to single leg squat or load-bearing squat on the basis of the original squat, so as to improve the strength and quality of students' lower limbs.

5.2 Innovative strategies of adding physical elements to the content of quality development activities

Any physical activity is completed under the coordination of all muscles, and the physical quality is also interdependent in various physical activities. All activities are dominated by one of the physical qualities, and multiple physical qualities are coordinated to complete. Primary and secondary school students are in a sensitive period of physical development. To increase the elements of physical fitness in practice is conducive to innovative comprehensive activities and promote the overall development of students. For example, taking the "three pieces chess" project which is dominated by speed quality in the quality development project as an example, we can increase the rope ladder obstacle race in the process of moving, strengthen the speed quality, and increase the stop or go password in the process to strengthen the sensitive quality. In addition, increase the distance between the two points to strengthen the quality of endurance and strength. At the same time, a variety of physical qualities should be strengthened to increase the interest of the game and arouse the enthusiasm of students, to promote the overall development of students.

6. THE INNOVATION STRATEGY OF ORGANIZATION MODE OF SPORTS ACTIVITIES BETWEEN CLASSES

There are many forms of organization of campus largescale recess sports activities. In addition to the alternative activities in the morning and afternoon and the three link continuous sports [15], the best

organization mode can be selected in combination with the activity content to avoid the single collective activity mode. Moreover, the activity organization mode can break the traditional class collective activity mode. Taking the grade as the whole, the students are divided into homogeneous groups or heterogeneous groups, and then the activities are completed in groups, which can enhance the curiosity and freshness of unknown teammates, strengthen the communication and expression ability of students, and cultivate their adaptability. In addition, we can also adopt the activity organization mode of individual competition in class to cultivate the competitive spirit among students. On this basis, it can be combined with a variety of organizational methods, such as taking the class as a group to challenge, and each class is divided into several groups. Finally, the total score of each group is evaluated to select the best group. However, there is competition among individuals in each group, and the best individual is selected according to individual performance.

7.CONCLUSION

The innovation of sports activities between classes should be combined with the trend of the times. The traditional and single way of activities is no longer in line with the concept of personalized development of students. Therefore, we should constantly introduce new elements into the large recess sports activities. In the process of innovation, we should take the participation of all teachers and students, stimulate students' interest in sports, and improve students' physique. We should always grasp the safety principle, optional principle, innovative principle and educational principle. We should innovate the content of large class sports activities by consolidating or adding physical elements in the content of quality development activities, and combine quality development training with physical training In order to further promote the construction of school physical education and deepen the reform of school physical education, it is necessary to innovate the organization mode of large class sports activities and enrich the contents of sports activities between classes.

4. THE EFFECT OF DISCUSSION METHOD IN ENVIRONMENTAL TOXICOLOGY TEACHING

Before discussing the specific problems, the teacher should form a study group, divide the students into different groups, and then assign them to different groups. Generally, there are about 6-7 members in each group, so that the students can actively express their opinions. For example, through the discussion of carbon monoxide poisoning, students can understand the whole process of carbon monoxide and human tissue reaction, and understand the corresponding symptoms. Let students clearly master the reaction equations of oxygen and hemoglobin and carbon monoxide and hemoglobin, and the specific performance is as follows: HB + O2 = HBO2 (i.e. under normal conditions, hemoglobin combines with oxygen and provides oxygen for inverse reaction)

HB + CO = HbCO (when inhaling carbon monoxide, the reaction equilibrium constant is as high as 460, so hemoglobin fails and causes hypoxia poisoning). In this way, students can better grasp the harm of carbon monoxide poisoning to human body through the understanding and understanding of chemical equation. 4.2.2 Report the results of the discussion

Since the problems to be discussed by each group are different, after the analysis and discussion of the study group, a student can be recommended to speak as a representative to express the process and conclusion of the group discussion, and then let the whole class analyze and discuss together. In this way, all the students in the class can participate in each problem and finally make the whole class work together Exhibition and progress. By reporting the results of the discussion, students will be able to have a more in-depth and comprehensive understanding of the problem. In the teaching process of toxicology, there are many problems that need to be discussed by the study group, most of which are due to the mutual transformation between Environmental Biochemistry and some complicated problems. In the process of actual group analysis and discussion and class communication, teachers should fully understand the students' actual situation and learning basis, guide students to participate in the process of analyzing problems, create opportunities for each student to actively express their opinions and suggestions, and let students organically combine their own ideas and knowledge theory to guide them Students give full play to their subjective initiative. This can not only improve students' selfconfidence in learning, but also help students better understand the teaching content of toxicology. Moreover, as a teacher, he should be able to control the teaching progress and classroom rhythm, and teach solutions and skills to the problems raised by students, so that students can learn targeted [5].

For example, in the teaching process of air pollution in toxicology, the main reason is that chemical production and exhaust emissions have caused environmental pollution, which will seriously affect human life and health. Therefore, for this problem, teachers should assign the current environmental problems as teaching discussion problems to students, so that students can comment on current affairs and discuss solutions and measures.

4.3 Summary

The main purpose of induction and summary is to deepen the problems that have been discussed, and teachers should give relevant comments according to the problems to be discussed, point out the wrong understanding and guide students to explore solutions. According to the actual investigation and analysis, it can be learned that the discussion method in the toxicology teaching process can cultivate and enhance students' interest and enthusiasm in learning, which can enable students to play a subjective initiative in the specific learning process, actively absorb and apply knowledge, and ultimately achieve the teaching purpose. In the process of application and improvement, students have a deep understanding of the discussion learning method, and can pay attention to its role and significance. Therefore, the discussion learning method has been recognized and affirmed by students and teachers. According to the survey of students and teachers, more than 50% of the students will recognize the role of the discussion teaching method, and more than 60% of the students think that the discussionbased learning method is very effective in improving their self-confidence and team spirit, and plays an effective role in improving the learning atmosphere [6]. 5. THE PROBLEMS THAT SHOULD BE PAID ATTENTION TO IN THE APPLICATION OF DISCUSSION METHOD

5.1 Teachers should be able to design problems in accordance with the syllabus

When designing problems, teachers should be able to carry out specific work according to the requirements of the syllabus and teaching task objectives as the main considerations, implement teaching work according to the important knowledge points in the teaching content, and meet the specific needs of students. If the design of the problem is more complex, then students will have conflict psychology, if the problem is designed relatively simple and superficial, it is not conducive to the further development of teaching work, but also affect the cultivation and improvement of students' quality and ability. And in the design of problems, students should be able to fully refer to the relevant factors in daily learning, so that students can more visually grasp the content of toxicology knowledge, to solve the problem. Therefore, teachers should be able to design problems to meet the requirements of the syllabus, in order to meet the needs of teaching work. 5.2 Be able to create opportunities for students to think and analyze problems

The traditional teaching concept and mode have no chance for students to think and analyze problems, while the discussion method needs teachers and students to actively interact. In the process of specific interaction, teachers should pay attention to control the

rhythm and atmosphere in the classroom, and avoid students' aimless discussion without thinking. If there is a lack of thinking, then students will not express their own opinions and suggestions for the issues to be discussed, but only carry out analysis and discussion based on the surface, unable to go deep into the essence of the problem, so the effect and quality of the discussion will not be affected. Therefore, in the process of application of discussion method, teachers should be able to create opportunities for students to think and analyze problems, so that students can apply discussion method to study [7].

5.3 Effective use of other teaching technology and equipment

Discussion teaching method in the specific application process, as a teacher should effectively use other teaching technology and equipment, such a combination of a variety of teaching methods, and scientific and reasonable application can promote the improvement of efficiency and quality of discussion method. If the discussion teaching method is simply applied, it will lose the unity, and will affect the development and implementation of teaching work, and ultimately affect the improvement of teaching effect.

5.4 Accepting different discussion results

As each student's learning situation is different, and students' knowledge and understanding of knowledge are also different, so teachers should pay full attention to this difference of students. Because the students' cognitive level of the problem is different, the final discussion results will be different, so the teacher should accept different discussion results and give different students the opportunity to express their views. The diversification of the results can not only improve students' self-confidence, but also help to create a good classroom teaching atmosphere, so that students can be more recognized and affirms the application effect of discussion teaching method. The discussion in class mainly depends on whether the teacher can design meaningful questions to attract students' attention and interest. This will help students to participate in the process of analyzing and discussing problems, and stimulate students' enthusiasm to think and discuss problems, to let students express their views and opinions [8].

6. CONCLUSION

The effective application of discussion teaching method has essentially changed the traditional teaching concept and mode, enabling students to actively recognize and master knowledge theory, and can play their own creativity and imagination, and improve their language expression ability, to improve the overall quality and ability of students. Therefore, the effective application of discussion teaching method needs teachers' deep attention, and when designing problems, teachers should make full use of the requirements of the syllabus and the actual situation of students. Such targeted problems can effectively improve the students' learning enthusiasm and quality. Therefore, the

scientific and reasonable application of advanced teaching mode plays an important role in the development and implementation of teaching work, and has an important significance for teachers' teaching and students' learning.

Due to the existence of "short board effect", the efficiency of the whole management system can not be improved.

- 4.1 Build information collaborative communication subsystem to realize information collaborative communication

Collaborative communication subsystem is a kind of systematic management technology internal function, using this subsystem can achieve centralized management of enterprises. In the subsystem, it presents grid management, builds a high-end radiation platform, and radiates outward. In this grid, we can judge by comparing and analyzing the services of similar logistics enterprises, search for relevant information, and then expand more functions of similar logistics entities through the information. This kind of system has high efficiency, can let each department of the enterprise and each supplier carry on the equal cooperation and the communication, get rid of the malpractice of the traditional information exchange way. Only one subsystem can realize the information interaction of all suppliers, without one-to-one contact, thus reducing the cost of collaborative management. In addition, the subsystem only needs a main network to run, has super smooth-running speed, and can timely and effectively match different information for enterprises. Through the subsystem information exchange platform, the supplier's requirements can be timely fed back to the enterprise, realizing the interconnection between the two sides.

4.2 Build a Collaborative Procurement subsystem to realize the coordination of procurement and distribution

In addition to operation communication, as a more important part of logistics enterprise procurement, it also needs to achieve enterprise collaborative management. The quotation of the logistics industry is determined according to the market demand. After the information exchange, the logistics service is changed.

Accordingly, the procurement work is needed to maintain this service. The purchase price needs to be adjusted according to other management and coordination enterprises, to protect the economic interests of enterprises. Therefore, we should build a Collaborative Procurement subsystem to realize the collaborative cooperation of procurement and distribution scope, to standardize the behavior between enterprises and suppliers.

Therefore, it is necessary for colleges and universities to assess the recruitment and training of talents. In addition, some staff who are not active and enterprising in the construction of high-quality students need timely reminders from colleges and universities. Some staff who have made great contributions to the base construction need to be recognized and rewarded. For example, colleges and universities regularly select "excellent and high-quality student source base workers" and "managers" according to the situation of the base construction, to improve the enthusiasm of the staff.

At the same time, the physical education curriculum arrangement in higher vocational colleges is very lack of rationality, and even some schools have no systematic sports teaching items every week, which makes students' sports spirit have no room to play, and it is difficult to show vocational education ideas, and can not exercise students' body well. This lack of practical curriculum arrangement has a great impact on students' comprehensive training Raise.

2.3 No advanced curriculum resources

At present, in most of the sports teaching activities in higher vocational colleges, there is a shortage of educational resources, and physical education is no exception. First of all, physical education in higher vocational colleges is lack of curriculum resources carrier in theoretical guidance, and students almost rely on Teachers' oral instruction as guidance; secondly, sports teaching lacks advanced sports facilities as auxiliary teaching projects, and students' sports skills are limited; finally, physical education under the background of vocational education lacks the support of curriculum resources, and only relies on theory to strengthen It is difficult to improve students' professional practice skills. 3.3 Integrate social and professional characteristics to show the concept of career promotion

The goal of talent cultivation in higher vocational colleges is to cultivate high-quality applied talents for the society, and to fully meet the quality education objectives of our country, to promote the improvement of national comprehensive quality. Based on vocational education as the guide of physical education in higher vocational colleges, from the perspective of talent output, more integration of students' vocational learning characteristics can effectively promote the strengthening of students' professional skills, but also can improve students' professional practice ability, so that students can also promote the enhancement of social application skills in sports classroom learning. 3.3 English translation methods of gourd

In addition, translators can use literal translation method to translate "cucurbit" into English,

In short, in the process of translating Chinese cultural symbols into English, there are mainly two kinds of annotation methods, one is transliteration annotation, the other is literal translation annotation [4]. In view of the great differences between Chinese and Western cultures, it is necessary to translate Chinese cultural symbols into English In the process of translation, we often encounter the phenomenon of word meaning vacancy, that is, the cultural words in English can not find the corresponding words in Chinese. Therefore, in the actual English translation, translators often use the annotation method to solve the problem of word meaning vacancy. For example, by supplementing the information of the origin of words and background information, we can deepen the readers' understanding of the connotation of Chinese cultural symbols.

3.4 English translation of Chinese wedding ceremony "Chinese wedding" has a strong national and regional characteristic, whether it is dress or etiquette, all show a high degree of knowledge and attention. Therefore, in the process of English translation of "Chinese wedding", if only literal translation is used to translate it into "traditional Chinese style wedding", it is difficult to vividly show the cultural essence and cultural connotation. At this time, translators can translate "Chinese wedding" into English based on functional equivalence. Functional equivalence refers to the process of translating two languages into English to ensure that the two languages achieve functional equivalence in terms of vocabulary, style, and semantics. For example, "sedan chair" as a common Chinese word for greeting brides, its decorative color is mainly red [5]. The whole decoration is very gorgeous, symbolizing the happiness and auspiciousness of the new couple entering the marriage. If the literal translation method is adopted to translate it into "sedan chair", it can not vividly show the function and value of the source language. Therefore, the translator needs to translate "Huajiao" into "a bridal sedan chair, which was heavily decorated with carvings, glided patterns, and colored beads hanging from the top of the the target audience will have a deeper understanding of the meaning of "sedan chair". For example, in the process of translating "worship heaven and earth" into English, translators should not use literal translation to translate it into "baitiandi", but should translate it into "bow to heaven and earth as part of a weeding ceremony" based on functional equivalence, which is more conducive to the target audience's understanding and understanding. In a word, in the process of translating Chinese cultural symbols into English, translators should try their best to convey more textual meanings from two aspects of reference and pragmatics, namely literal translation, transliteration and annotation, to achieve accurate interpretation of the connotation of cultural symbols.

4.CONCLUSION

To sum up, Chinese cultural symbols have strong regional, epochal, and national characteristics. As an important means of cultural communication, English translation needs translators to grasp the relationship between the source language and the target language, and adopt literal translation, transliteration and other English translation methods to ensure that the translation is as faithful as possible to the original text, so as to translate the real connotation of Chinese cultural symbols into English In the process of translating Chinese cultural symbols into English, on the basis of fully grasping the cultural connotation of the original text, we should adopt the method of adding notes to improve the understanding depth of the target audience, so as to achieve the purpose of effectively spreading Chinese traditional culture.
